<u>Gun Storage</u> is available at the venue for a daily charge and cartridges are available at market rate. For storage and cartridge orders these should be confirmed directly with the venue 10 days prior to arrival. Some limited camping pitches will be available at the venue and must be booked in advance. The main contact at the venue is: Andrew McCaig.

<u>Practice</u> will be available at the National Shooting Centre Scotland every day during the week prior to the event from 10.00–19.00, including a 100 DTL SCTA Selection/Registered Shoot on Saturday 15th July.

The **Home Countries International Tournament (HCIT)** on 20th July and **British Open** on 21st July will be 100 targets each day. Teams will consist of the following:

Seniors:	Teams of 20 (16 scores to count)	
Ladies:	Teams of 5 (4 scores to count)	
Juniors:	Teams of 5 (4 scores to count)	(under 21 on 1/1/2017)
Veterans:	Teams of 5 (4 scores to count)	(55 or over on 1/1/2017)
Super Veterans:	Teams of 5 (4 scores to count)	(65 or over on 1/1/2017)

<u>The entry fee</u> is £30.00 per person for the HCIT competition and £50.00 per person for the British Open competition. Please ensure that all Teams are submitted on the attached ICTSC Team Submission Form.

<u>The Draw</u> will take place at **2pm** on Wednesday 19th July. All Team Managers requested please to be in attendance for the draw.

<u>Trophies</u>: Please ensure that all trophies for the HCIT & British Open are returned to the ground no later than 2pm on the date of the draw. Alternatively secure facilities have been arranged at the Inchyra Hotel and you may drop them off there, again prior to 2pm on 19th July.

The **European Championships** will be held over two days of 100 targets each day (200 in total). The European National Team events (maximum 3 Teams per country per category) will consist the following:

Open:	Teams of 5 (all scores to count)
Ladies:	Teams of 3 (all scores to count)
Juniors:	Teams of 3 (all scores to count)
Veterans:	Teams of 3 (all scores to count)
Super Veterans:	Teams of 3 (all scores to count)

The entry fee for the European Championships is \pounds 100 per person with Team fees of \pounds 50 for the Open team and \pounds 30 each for the L/J/V/SV Teams.

The closing date for all entries is: Sunday 2nd July 2017.

Visitors Permits

The following is extracted from the Police Scotland website:

An application for a visitor who wishes to possess firearms to which section 1 of the Firearms Act 1968 applies, or possess, purchase or acquire any ammunition to which that section applies whilst in Great Britain or to possess a shot gun to which section 2 of the Act applies must be made via a person resident - 'a sponsor' - in Great Britain

The only criteria to act as a sponsor is to be of good character, and it is not necessary to be firearm or shotgun certificate holder. We [Police Scotland] will only deal with the sponsor.

The application for the permit is made by the sponsor and should be accompanied by the appropriate fee. [*If you don't currently have contact with a sponsor, information about sponsors will be published on the SCTA website soon.*]

The cost of visitors' permits charged by Police Scotland is:

Visitor's permit: Individual - £20 Visitors' permit: Group (six or more permits) - £100

Application for a Visitors' Permit Form 107 is available below.

This form can be downloaded direct, or you can obtain one from any Police Station.

Currently it is not possible to submit these forms electronically.

The applicant should also supply an original or a full copy of the European Firearms Pass if the permit is requested by an EEC resident or a copy of the visitor's hunting permit valid in their home country or Certificate of Good Conduct - available from the visitor's home police/sheriff department.

Applications for a Visitors Permit should be made at least 6 weeks prior to arrival in Scotland. There may be extenuating circumstances when an application is made close to the date on which the applicant wishes to travel to Scotland. Police Scotland will make every effort to process late applications on time, however this cannot be guaranteed
