## **ENGLAND TEAM UNIFORM**

For any shooter gaining an England Team place it is mandatory to acquire, as a minimum, an official England team dress uniform as described below. Furthermore, an official jacket and shooting vest must be purchased through the CPSA. A pack containing all details of CPSA requirements for International events will be given to shooters gaining team places when the results of the selection shoots are known. All necessary badges, pins, stickers etc associated with England Team must be obtained from CPSA Head Office.

## SHOOTING UNIFORM

For the Commonwealth Games, if the event organiser [Chandigarh, 2022] provides a shooting uniform, it must be worn. In the absence of any organiser shooting uniform being available, the official England shooting uniform will be worn. The official England shooting vest and jacket, trousers of your choice (No denim jeans for this event), England shooting cap (Optional). All other garments must comply fully with the official CPSA dress code.

## **DRESS UNIFORM**

The England Team Dress Uniform, in which official photographs are to be taken and which must be worn by all the team members when requested by the manager, is made up as follows:

**Men**: Navy Blue Blazer with wire England shield badge on the breast pocket, mid-grey flannel trousers, white shirt with collar, CPSA England tie, grey socks and black shoes

**Women:** Navy Blue Blazer with wire England shield badge on the breast pocket, knee length midgrey skirt or grey trousers, white shirt with collar, CPSA England tie or cravat and black shoes

Team members must obey the instructions issued by the CPSA appointed Team Manager at all times. Failure to wear the correct uniform or act as instructed will exclude any shooter from taking part in the event and will subsequently result in disciplinary action being taken by the CPSA against the individual(s) concerned.
